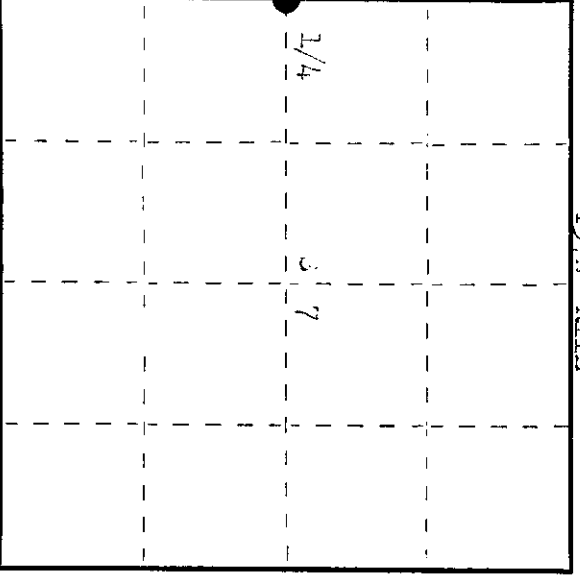
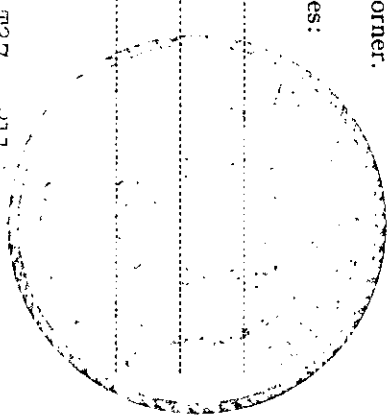
I Phillip T. Hansen, do hereby certify that on the 16th day of September, 1976, I found evidence of the quarter corner of section 7 & 12 Township 37, North, Range 10 & 11 east, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner.

History of original corner establishment:

Original corner established by Hiram J. Fellows, Deputy Surveyor, in 1859, Tamarack 3" bears S 15° W 17 links and Tamarack 9" bears S 80° W 25 links. Corner recovered by V...aine, County Surveyor, in 1935. Claims to have found a very old scribed post and stump of original tamarack S 80° W 25 links, also found part of another old stake deep down in moss. Set new scribed post and marked with spruce 5" N 32° W 25 links, spruce 4" N 35° W 6 1/2 links. Corner recovered by Blm. in 1959. Set iron pipe with brass cap.

Description of corner evidence found:

recovered. Blm.'s old 3" squared spruce post section 1/4 - 1/4. Also recovered Blm.'s 2" iron pipe with 3" brass cap projecting 9" above ground. recovered 5" N 32° W 25 links, now a decayed stump. spruce 4" N 35° W 6 1/2 links, now a decayed stump. spruce 5" N 30° W 10 links, scribed 1/4 - 1/4 Blm. now dead. spruce 4" N 10° W 25 1/4 links, scribed 1/4 - 1/4 Blm.

Description of monument and accessories I established to perpetuate the original location of this corner.

As the Blm. monument is in perfect condition, left in place, set an 8" picket with blue flagging next to it. This cap is scribed: U.S. District Survey 1/4 Blm. Black spruce 5" N 34° W 5 1/2 links, scribed 1/4 Blm. Black spruce 5" N 30° W 40 3/4 links, scribed 1/4 Blm. All was removed to Blm. monument.
